J Stokes – a true stalwart of the club, who is sorely missed. The AGM would like to see the club recognise Jimmy in some way, and this action is passed to the incoming Board to organise.

Minutes of the Previous Meeting:

The minutes of the 113th A.G.M. were read and confirmed as being a true and correct record.

Matters Arising From the Minutes:

There were no matters arising.

Presidents Report:

The President's Report was read and accepted.

Chairmans Report:

The Chairman provided a verbal update to the meeting. The Chair thanked K Davies for his efforts for the club to keep it on a solid financial footing through COVID-19 years, and thanked all club members and supporters for their continued support.

Club Captain Report:

The first team coach provided a report on behalf of the Club Captain. There was a question from the floor in regard to why there was no report from the Club Captain, who explained that time constraints and work pressures had meant this was not possible. Also, that J Hill was closer to the development of the top sides and could report more accurately.

The AGM indicated that was no mention of the Masters sides and that it would be preferable to have a whole of club report, rather than just the senior men's teams.

Women's Report:

The report was read and accepted.

Women's football at SAFC continues to go from strength to strength. There is a new coach for the 2023 season and Bri Krekoski is doing a magnificent job for the club.

Capital Football is putting in place a revised structure for Women's football, to try to grow and improve it. This will create a large requirement for coaching staff which the club will need to consciously work towards.

Junior Club Report:

The Junior Club Report was read and accepted.

There is a meeting on Saturday 11 February 2023 for junior parents to talk about the upcoming season and them taking a greater role in the organising of the junior side of the club. T Hills was commended for his sterling efforts over the last 10 years for SAFC, and for the handover material that he has provided. It was also recognised that there is a need to support coaching in the junior side of the club. This will be a focus of the season coming up.

Financial Report:

Subscriptions:

The outgoing board did not submit a proposal for subscriptions, therefore the AGM discussed subs at the meeting.

The Chair described 3 options that were available to the club:

- 1. Do nothing and leave fees flat from the 2022 season
- 2. Increase fees in line with the increase in fees from Capital Football (5%) or even at the current rate of inflation (7.5%)
- 3. Put through a small increase (say 2%) to reflect increasing prices but lessening the burden on players and families.

The attendees agreed that, given the overall economic environment and the increased fees from Capital Football of 5%, subs should be increased for the 2023 season. However, the meeting agreed that the option of limiting the increase to 2% for the next season ensures that the financial burden upon the club's members would not increase too significantly. The AGM discussed the non-playing members/associate member voluntary fee of \$20 and agreed that this should be more widely publicised and increased to \$50.

All attending were in favour of adopting the subscriptions as laid out above.

General Business:

The Chair informed the AGM that the outgoing Board had nominated T Hills for life membership of the club. The AGM fully endorsed this, and T Hills was duly elected as a life member of SAFC.

M McCaskey informed the AGM that player recrement in the Over 45s space was required in order to maintain the Originals. The club will support that team with a recruitment drive and advertising and putting out a general request for new players.

D Van Kampen indicated that there may be a team (or part of a team) that may be keen to come across to SAFC. He will make contact.

C Tooley enquired whether the club should advertise more widely, maybe a letter drop to all the houses surrounding the park espousing the virtues of the club and encouraging people to come along and join as social members or sign up to play.

The AGM also discussed whether the club should provide membership cards. The meeting agreed that the club should, and J Bishop will make contact with Prestige Print to try to get some made up in line with the cards that had been prepared a few years ago.

In line with this discussion, J Hill commented that the new website is up and running which is great, but the club needs to invest more time, energy and resources into increasing the online profile of the club through social media. The AGM directed the incoming Board to look at ways to achieve this.

The AGM also asked that the incoming Board re-assess the costs of having credit card and payWave facilities over the bar. The cost previously had proven to be a stumbling block but with the increased use of additional fees at the terminal for the use of these facilities, it may become more palatable for a small club such as SAFC to implement. K Davies was tasked to revisit this and present to the incoming Board.

Being no further business, the meeting was closed at 8.40 pm.

A big thanks to David "Cappy" Capstick for his tireless work behind the scenes as well as making the long trip from Porirua for our Thursday practice and post practice beer. David has gone over and above what anyone could ask as an assistant coach / manager and his loyalty is something I admire so much. Also, a big thanks to Luis for stepping into the Cap 2 coach role and helping me consistently over the season with his perspective.

In 2025, the new Central League 2 format comes into play so the results in 2024 will have a big consequence on that. Other Senior Men's teams

The Men's third team and the U17 team had good seasons in terms of playing, but, as mentioned in the Presidents report above, were not hugely supportive of the club in terms of their presence in the club rooms or the payment of the subs due.

Masters

It was another pretty standard start to the season for the Masters 2 team, with player numbers around the 17 mark, however that grew to a final number of 25. Yet that still didn't stop the normal scramble for players for a number of weeks. Eventually we managed to have about the right numbers consecutively without too much Friday night scrambling. Once past the first couple of games we started on a really good roll, eventually hitting a 12-game unbeaten run.

The season went really well, with only a couple minor injuries, and one major injury which required a number of surgeries unfortunately for that player. I tried getting the team to train, but that was tough with ground availability and enthusiasm. We managed about 5 weeks, and then numbers just weren't turning up so more thought might be required on that for this year. One issue was the grounds, and having to play on substandard surfaces, namely Crawford Green. This was mainly due to poor foresight of Capital Football not postponing or changing the game location early enough.

Then we find ourselves at the final game, playing second to bottom, having the best defence in the group, backed up by a 12-game unbeaten run we were pretty confident. And it is worth noting that even capital football thought so turning up to the game pre-kickoff holding out the silverware. Unfortunately, the game wasn't our best and we lost it, which meant we then had to wait another week for a weird result that inevitably did not go our way. After all that though, promotion was gained finishing 2nd only by an account of 59 goals scored compared to Upper Hutts 66.

Though not a great way to finish, this game was in no way a reflection of how the team played throughout the season. There was huge heart and commitment from every player. The team went from strength to strength, and I really hope everyone is looking forward to another season next year!! All be it a tad harder in Masters 1.

WOMEN'S REPORT 2023

It was another successful year at the club for women's football. We again hosted three teams and with over 60 women supported to play football through Seatoun AFC. It was also a year for female leadership, with each of our three teams being headed by a female coach! A big thank you to all of the managers and partners behind the scenes who supported, we couldn't have done it without you!

2023 was the year of the FIFA Women's World Cup in NZ and Australia. What a great time for girls and women's football in NZ. As part of the World Cup legacy programme clubs were supported to participate in new initiatives. A highlight of the year for the women's and juniors space was participating in the Fantails Programme. Fantails is for girls aged 5–12 years, to try football for the first time or continue playing in a fun, safe environment. The Seatoun Fantails programme was supported by our women's central league team and for the first time in a long time, our club saw juniors, youth and women's players enjoying the game together.

Another exciting opportunity the World Cup brought to our door was the FIFA validation match at Westpac Stadium. The women's central league team (supported by division 1 players) played Waterside Karori behind closed doors at the stadium two days before the opening match of the World Cup. The teams tested all the processes and technology that were to be used in the official matches, right from parading out to national anthems, to penalties, substitutions and goal line technology. It was an experience the players will remember for life.

Central League

Headed by Coach Bri Krekoski, assisted by Fahim Afarin Asadi, the women's central league team finished 5th in the league on 12 points. Bri hit the ground running, bringing her years of experience, embedding best practice into training and games; strength and conditioning warmups, ice baths, sports psych and nutrition sessions to name a few. Fahim built in his unmatchable enthusiasm for the game and encouragement of players. The team finished in their highest place in a number of years, and we want to thank both coaches (and Kris) for their contribution. On the pitch the team was committed and relentless. They focused on embedding a defensive model to build from and the team had some excellent results against top and bottom of the table alike. The top two teams in the central league are now eligible to enter the National Women's League (NWL). As such, Seatoun loaned three players to those top two teams: Katia B (Karori), Ellie K and Cara C (Wellington United). All three players had a huge impact in the NWL - well done!

Division 1 (Sea Shanties)

Headed by Coach Renata Sain, assisted by Fahim, the Sea Shanties finished round 1 in 3rd place on 16 points and round 2 in 7th place on 10 points. As Renata said at the beginning of the season, this was the year of 'a little bit more'. The Shanties had enormous success in the 2022 season and this year was about refinement and embedding the coaches game plan and building a great culture. The team produced some excellent results and played an exciting style of football. This season saw both division 1 players playing in central league and central league players playing in division 1, thank you for supporting both teams. The season wouldn't have been as successful as it was without the management support of Jemma! A big thank you to the players, coaches and manager for your commitment and contribution to the team and the club.

Division 3 (Seagals)

Headed by Tash Ingram, assisted by Fahim, the Seagals finished their round 1 in 8th position on 13 points and round 2 in 11th place on 8 points. The Seagals have well and truly established themselves in division 3 and at our club, having enjoyed three solid seasons. A number of players have committed to the Seagals since the beginning, a shout out to you for holding it down! Player experience and knowledge of the game continues to grow and it's exciting to see. We sadly said goodbye to an OG Seagal and Manager extraordinaire, Aggie. Aggie's contribution to the team has been outstanding, but she left the reins in the capable hands of Lorelai. The season also saw Coach Tash have to take medical leave for two months and in their absence Fahim stepped in to impressively fill the void. The season finished with both coaches at the helm, and we can't thank them and the managers enough.

JUNIOR / YOUTH REPORT 2023

Seatoun AFC has a long history of supporting junior and youth football over several decades. Over the past few years, numbers have fallen, and a lack of support in the junior space has created some logistical, resource, and relationship strains in the community and junior's club. In the 2023 season, SAFC employed a program development/junior convenor lead (Bri) to reignite the junior side of the club. Although there were both struggles and initial successes, the process of reinvigorating the junior club is a multi-year process.

For the first year, the programme managed to build interest in the game in a number of key areas. There was the launch of the Fantails programme to encourage girls to participate in football, an increased programme of holiday and after school activities and an increased approach to communication and involvement through the TeamSnap system.

The feedback gained at the end of the season from the parents of the players was that the season was largely successful (apart from the weather not always playing ball!) and that there was a lot of enthusiasm for kids to come back next season and for us to build upon the successes.

The prize giving for juniors this year was organised a little differently, with all participants in the season being recognised rather than individual players within a team gaining the trophies. This was largely well received by the junior side of the club, and we look forward to welcoming everyone back in the 2024 season and building upon the successes so far.

The coming season will be the next stage on the development journey for the junior side of the club, where we aim to be able to provide an increased level of investment in kit and training opportunities, as well as accessing all of the great opportunities for more people to become involved in the club.

NOTE:

1 STATEMENT OF ACCOUNTING POLICIES

The financial statements presented here are for the reporting entity Seatoun Football Association Club Inc. Seatoun Association Football Club is a non-profit organisation incorporated under the Friendly Societies Act.

(a) GENERAL ACCOUNTING POLICIES

The general accounting policies recognised as appropriate for the measurement and reporting of results and the financial position under the historical cost method are followed in the preparation of the financial statements.

(b) SPECIFIC ACCOUNTING POLICIES

Revenue

Seatoun Association Football Club derives revenue from subscriptions, and from other funds raising activities including grants from community bodies. This revenue will be recognised and reported in the financial period to which it relates.

Debtors and receivables

Unpaid subscriptions are not recorded as receivables as it is considered that the cost of collection generally exceeds the potential proceeds.

Bar

Seatoun Association Football Club operates a bar for after match, and special functions. Appropriate licencing is obtained as required.

Fixed assets

Fixed assets purchased are recorded at cost.

Depreciation rates

Depreciation is provided on a straight-line basis at rates that will write off the cost or valuation of the assets, less their estimated residual values, over their expected useful lives. Useful lives of the major classes of assets have been estimated as follows:

Goods and services tax

Goods and services tax (GST) is accounted for on an invoice basis.

Revenue and expenditure items are disclosed net of GST.

The Statement of Financial Position is exclusive of GST except for Payables and Receivables. All other statements are exclusive of GST.

Changes in accounting policies

There have been no changes in accounting policies since the date of the last audited financial statements. All policies have been applied on bases consistent with those used in the previous published financial reports.

RULES OF THE SEATOUN ASSOCIATION FOOTBALL CLUB INCORPORATED

1. The club shall be called the Seatoun Association Football Club Incorporated and its object shall be the promotion of the game of association football and other recreational activities and the provision of facilities, equipment and amenities for them. The club's funds shall be applied only in the furtherance of the objects of the club.

Membership

- 2. The club will keep a register of all members.
- 3. The club shall consist of present financial paying members, officers of the club, committee members, honorary members and team officials together with those who may hereafter be elected by a two-thirds majority of the Committee or a General Meeting of members.
- 4. Any member wishing to leave the club shall forward his/her resignation to the Secretary in writing before the Annual General Meeting otherwise the subscriptions for the then ensuing year will be considered due.
- 5. Any member of the club having refused to comply with Rules of the Club, or in the opinion of the Committee having acted in a manner likely to bring the club into disrepute, may be called upon to resign by the Committee and in default of so doing may be expelled by a majority of votes at a General Meeting of the club. If a member resigns or be expelled from the club under this rule his/her subscription shall be forfeited. Members who have defaulted on the payment of a subscription for two years will be deemed to have resigned from membership of the club.
- 6. Honorary members shall pay an annual subscription determined by the Annual General Meeting and shall have voting rights at General Meetings.
- 7. Any person who has rendered special service to the club (10 years service and / or 20 years membership of the club) may be made a Life Member at an Annual General Meeting upon the recommendation of the Committee.

Rules

8. These rules may be altered, rescinded or added to provided that it is done with the consent of the majority of members present at a General Meeting of the club which has been convened with at least seven days prior notice.

9. The Committee may make, alter or rescind by-laws from time to time provided that they are not repugnant to the Rules or the Act.

Meetings:

- 10. The Annual General Meeting shall be held no later than 14 February of the following calendar year. Not less than fourteen days' notice shall be given for every General Meeting.
- 11. Special General Meetings may be called by order of the Committee or upon the written application of twelve members. Not less than seven days' notice shall be given of any such Special General Meeting. Special General Meetings shall consider only the notified agenda.
- 12. Meetings of the committee shall be held as required. Special Meetings of the committee may be called by the Secretary or upon the requisition of three committee members.
- 13. At all General Meetings, fifteen shall form a quorum (including at least one officer of the club) and at Committee Meetings four shall form a quorum.
- 14. In General and Committee Meetings, the Chairperson shall have a deliberative and a casting vote. The method of voting at meetings shall be by voices, show of hands or by ballot as directed by the majority of members present.
- 15. The Committee in meeting shall have the power to deal with all matters concerning the club not specially provided for these in rules.
- 16. Any member of the Committee who shall have absented him/herself from three consecutive meetings thereof without reasonable excuse shall be deemed to have resigned from the Committee.

Officers

- 17. The officers of the club consist of a Patron, a President, a Club Captain, a Secretary, a Treasurer and three Trustees who shall be elected by ballot at the Annual General Meeting. Nominations for all office bearers must be in the hands of the Secretary not later than 48 hours before an election.
- 18. Officers, Committee members and others as approved by the Committee may be paid a remuneration or reimbursed for their services as approved by the Committee.
- 19. The President, Club Captain, Secretary and Treasurer shall conduct the business of the club together with five other members (the Committee, to be known as the Board within the club) elected annually. Committee members may be allocated portfolios and convene sub-committees of members to help in the management of the club.
- 20. The Committee may elect a Chairperson from within the Committee or by default the President will chair committee meetings. The Chairperson will assume all delegated powers and responsibilities of the President if the President is incapacitated or is unable to fulfil the role.

- 21. The Committee shall appoint delegates, team managers, selectors and coaches and any other agents needed to act for the club.
- 22. The Committee shall define the roles and duties of the Officers and all others appointed to serve the needs of the club. The Committee shall monitor and report to the Annual General Meeting on the performance of Officers and any other appointees.
- 23. The Committee shall have the power to fill any vacancies.
- 24. The Committee shall have the power to set financial and non-financial delegations to individual Officers, members of the Committee or members of the club.
- 25. The Common Seal of the club shall be kept by the Secretary and shall contain the words Seatoun Association Football Club Incorporated. Every document to which one seal of the club shall be required shall be sealed in the presence of the Secretary and at least two members of the Committee, who shall attest the same.
- 26. The Club may, at a Special General Meeting called for the purpose, seven days' notice having been given, by resolution of the meeting remove the Trustees or any of them or the Committee as a body or individually for the time being of the club.
- 27. Any proposal to amalgamate the club in whole or in part with another club(s) may be approved, following the unanimous recommendation from the Committee, by two-thirds of all members of the club at a Special General Meeting called specifically for that purpose.

Funds and Property

- 28. The Trustees shall have control of the real property of the club and shall invest and use the funds arising therefrom for the general advancements of the club's welfare.
- 29. The Treasurer shall receive all monies of the club and give a receipt for the same, and he/she shall pay such monies into such bank as the Committee may direct. All cheques shall be signed by the Treasurer and at least one other nominated member of the committee.
- 30. The Secretary shall attend each Meeting of the club and Committee and keep minutes of proceedings, read and file communications and all other papers, issue notice of meeting when directed and conduct correspondence. He/she shall prepare the Annual Report and Balance Sheet and submit the same to the Annual General Meeting before filing an endorsed copy with the Registrar of Incorporated Societies.
- 31. The annual subscriptions for members of the club shall be determined by the Annual General Meeting.
- 32. The Financial Year of the club shall commence on the first day of November in each year and at the following Annual General Meeting the committee shall present a report on the previous year's transactions. The Treasurer shall prepare and report to the Meeting on all monies received and paid out on account of the club during the preceding twelve months ending on the thirty-first day of October and statement of assets and liabilities.

- 33. Any member whose subscription in arrears after due notice has been given is liable to be excluded from all matches or other club activities until payment is made. No unfinancial member of the club shall be allowed to neither vote at any meeting nor be eligible to take office.
- 34. If at any time the club, in General Meeting, shall pass a resolution authorising the Committee to borrow money, the Committee shall thereupon be empowered to borrow for the purposes of the club such amount of money either at one time or from time to time and at such a rate of interest and in such form and manner and upon the security as shall be specified in such resolution and thereupon the Committee shall cause to be made all such depositions of the club property or any part thereof and enter into such legal mortgages or charges containing powers of sale and other usual provisions in relation thereto as the Committee may deem proper, for giving such security for such loans and interests.

Disposition of property

35. Two-thirds of the members of the club at a meeting convened for the purpose, provided that all the liabilities of the club have been duly discharged, may resolve that the club be wound up as from the date to be named in such resolution, and may also direct the method of disposition of the funds and the property of the club upon the dissolution thereof to Capital Football to be used for the promotion of football.

Reciprocal Visiting Rights

36. All members and guests of all affiliated football clubs that fall under the NZ Football authority have the right to visit the club as invited guests. This means that all NZ Football registered club members and their guests will be able to enter and use our clubhouse facilities throughout the year, including purchasing and consuming alcohol on our club premises. The purpose of the visit can be local competition between clubs, Capital Football sanctioned competitions and all competitions under the control of NZ Football.

Complaints and Disputes

37. Any complaints or disputes must be made to an officer of the club who will ensure the matter is resolved (if necessary, by involving the Committee). All actions are to be recorded by the Secretary.
